

Terms & Conditions: Jands 2008 Whitsundays Promotion

9. Entry forms will be available from participating stores and on the Jands website www1.jands.com.au/news/promotions
10. To be eligible for entry into the Jands 2008 Whitsundays Promotion, completed entry forms must be received at the Jands Head Office, 40 Kent Road, Mascot NSW 2020, before close of business, 5:30pm Tuesday, 15 July 2008.

12. Entry forms must be completed in full and accompanied by the ORIGINAL purchase receipt to be eligible.
13. The original purchase receipt must have AUD\$750 (sale value) of the above products clearly stated.
14. Combined purchase receipts to achieve the AUD\$750 minimum value will NOT be accepted. One invoice equals one entry.
15. The original purchase receipt must clearly state the Purchase Date, Authorised Retailers Name & Business Address.
16. The original purchase receipt must be dated between 12:00am, Tuesday, 1 April 2008 and 11:59pm, Monday, 30 June 2008.
17. Incomplete entry forms or entries submitted without the ORIGINAL purchase receipt will be deemed ineligible.
18. The Salesperson's details who sold the goods must be filled out in full or the entry is deemed ineligible.
19. Jands will not be contacting any persons with ineligible entries.
20. The promotion will be drawn 3:00pm, Friday, 18 July 2008 at the Jands Head Office, 40 Kent Road, Mascot NSW 2020 and will be scrutinised by an independent person.
